Notes:

1. Toowoomba Anglican School proudly participates in the Queensland Government's Free Kindy program. The fee for the 3 and 5-day Kindy is inclusive of 600 hours of Free Kindy. The kindergarten 2-day program is not eligible for Free Kindy.
2. The General-Purpose Levy (GPL) is non-refundable and includes excursions, incursions, art supplies (excludes Years 9-12), curriculum sports transport, QCIS, TSSS, TPSSA and Andrews Cup fixtures, socials, camps (excluding trips and tours), eBooks and other computer programs (Excludes Years 9-12 electives).
3. The General-Purpose Levy (GPL) for year 6 includes the Year 6 Celebration evening (up to 3 tickets) and excludes the Year 6 Camp.
4. The General-Purpose levy (GPL) for year 12 includes one Year 12 Formal ticket.

*The boarder levy is non-refundable and is used for social activities and excursions.



FAMILY FEE CAP

The Family Fee Cap is available to all families regardless of how many students are enrolled across the primary and secondary school. Based on 2024 fees, this means the maximum a family would pay for Tuition is \$31,012 per year (\$7,753 per term), regardless of the number of children enrolled from Prep-Year 12. The Family Fee Cap will cover Tuition Fees only and is calculated based on the average School Fee x 2.5.

For example, a family with four children in Years 1, 3, 5 and 6 currently pays \$42,417 per year. A family with three children in Years 7, 10 and 12 currently pays \$44,996 and a family with three children in Years 5, 9 and 11 currently pays \$42,754. These families would all have their total tuition capped at \$31,012 per year. In order to qualify for the Family Fee Cap, you do need to be the biological parent and or legal guardian of all children.

As Australia's only coeducational K-12 Day and Boarding School offering Boarding from Years 1 to 12, we have always been a community that values family and inclusion, this is our way to show support for families during these years.

SIBLING DISCOUNT – 10%

A 10% sibling discount for the third and subsequent child at the school at the same time will apply. The discount will be honored for the balance of the third and subsequent children's education with Toowoomba Anglican School. This will apply to Tuition only, it will not apply to any other fees and charges. The discount also does not apply to students who are currently receiving a scholarship, bursary or any other form of fee assistance. The sibling discount forms part of the Family Fee Cap calculation.

UPFRONT DISCOUNT – 3%

A 3% upfront discount will apply on tuition fees only, if full payment of tuition and the general-purpose levy is received by 23 January 2024. The discount does not apply to students who are currently receiving a scholarship, bursary or any other form of fee assistance. The upfront discount forms part of the Family Fee Cap calculation.

TOOWOOMBA ANGLICAN SCHOOL FEE POLICY

1. Fees detailed above are effective from 1 January 2024 and shall remain in force until such time as changed by the School Council.
2. Whilst it is the aim of the Council to set fees on an annual basis, the Council reserves the right to change these at any time.
3. As specified in the agreement signed with the School, fees fall due at the beginning of the period they cover and are payable in advance. Each parent is jointly and severally liable for costs incurred by the School, including legal costs in recovering or attempting to recover fees or charges payable.
4. If families are unable to pay the fees by the due date, please contact the accounts office at accounts@taschool.qld.edu.au for advice.
5. In the unfortunate situation where fees are unpaid as at the due date and/or agreed arrangements are not being maintained, or after repeated failure to meet negotiated payment schedules then the School may:
 - a) apply an initial service charge of \$50.00 and then an additional \$50.00 per month or part thereof;
 - b) reverse any discounts or other reduction in fees (Including scholarships and remissions);
 - c) direct unpaid accounts to a Collection agency or the Small Claims Court and / or;
 - d) suspend or terminate the enrolment of the student/s.
6. A \$10 direct debit dishonour fee will be charged for each declined transaction.
7. ENROLMENT VARIATIONS – WITHDRAWAL OF STUDENTS
You may withdraw the student from the School by giving the Head of School at least 10 term weeks prior written notice of the withdrawal. If you withdraw the student from the School or change the status from boarding student to day student or postpone or vary the enrolment, you must still pay all tuition and boarding fees for the student for:
 - The term in which the notice of withdrawal expires; or
 - If the notice of withdrawal does not expire during a term – the term immediately following the date on which the notice expires (which, if the notice of withdrawal is given before the student starts at the School, will be the term in which the student was to commence at the School).You do not need to give notice of withdrawal when the student will be leaving the School after the completion of their secondary schooling at the end of Year 12.
8. Students who hold a Visa (excluding subclass 500), your visa must remain valid for domestic fees to apply.
